### **Tuesday, July 10, 2007**

### **Involvement of Intelligence Division CI in Shooting of 71 Precinct MOS**

- During the early morning hours of Monday, July 9, 2007, Police Officers Russell Timoshenko and Herman Yan, both assigned to the 71<sup>st</sup> Precinct were shot during a car stop. As of the writing of this report, investigators have linked three suspects to the incident with evidence that includes fingerprints of all three either on or within items recovered from the subject vehicle. The three suspects have been identified as follows:
  - o Dexter Bostic; M/B/34, DOB 09/01/1972, NYSID # 6258860L.
  - o Robert Ellis; M/B/34, DOB 04/19/1973, NYSID # 6843010K.
  - o Lee Woods; M/B/29, DOB 01/11/1978, NYSID # 7764954M.



- Woods (pictured above), the only suspect in custody at this time, is a Confidential Informant (# 07-240) registered with the Intelligence Division ("Tim"# 07-240). His registration information and activity summary as a CI is as follows:
  - o Address: 222 Beach 29<sup>th</sup> Street, Queens (Rockaway)
  - o Criminal History
    - Total Arrests: 9
    - Total Charges: 29 (9 felonies; 6 violent; 2 firearms, 16 misd.)

    - Date Earliest Arrest: 10/07/1993
    - Date Last Arrest (not including instant offense): 10/10/2006
    - NOT currently on Parole or Probation

  - CI transferred to Sgt. 101/FIO, on 03/11/2007 as a result of Sgt. 's transfer to the Internal Affairs Bureau
  - Alternate remains Sgt.

### o CI Activity:

- On 02/13/2007, CI was paid \$1,000.00 (Gun Stopper funds) for information which led to one (1) arrest and the recovery of one (1) .32 caliber revolver. Handled by Sgt.
- On 04/23/2007, CI was paid \$300.00 (IOAS funds) for information which led to one (1) arrest and the recovery of one (1) .25 caliber pistol and one (1) 9mm pistol. Handled by Sgt.
- On 05/11/2007, CI was paid \$300.00 (IOAS funds) for information which led to three (3) arrests and the recovery of one (1) 9mm rifle.
- On 06/30/2007, CI met with Sgt. and provided information on two firearms allegedly in an auto. No arrests made or firearms recovered.
- On 07/03/2007, CI contacted Sgt. and provided vague information on twenty (20) guns allegedly being transported from the South to NYC. No arrests made or firearms recovered.

- In summary, CI # 07-240 has provided information which has led to the arrests of 5 perpetrators and the recovery of four firearms. He has been paid a total of \$1,600.00 USC by this Department for that activity.
